#### (THEN) 1998



George Kaiser and 16 other Tulsa leaders founded TCF on December 30. The following year, TCF hired Phil Lakin Jr., as its first and only CEO, pictured here with Kaiser and former board chairs Joe Cappy and Bill Thomas.

# 2004

TCF and the George Kaiser Family Foundation coordinated with Tulsa Public Schools, the Community Action Project of Tulsa County, the state Department of Human Services, Family and Children's Services and several local donors to establish the **first Educare facility in Tulsa**. Today, Educare operates four early childhood schools in the community providing high-quality early learning to over 650 children and their families.



#### 2006

TCF facilitated **Step Up Tulsa**, a community planning initiative to increase Tulsa's international appeal, advance education, promote economic development, improve residents' health, and promote a sense of pride in the community.

"George Kaiser and the other founders hope that creation of the community foundation will increase charitable giving in northeastern Oklahoma and will encourage that charitable donations from this area are spent in this area. It will do that in several ways: by ensuring continuation of the original donor's charitable purpose, encouraging giving by donors who have not yet established local roots or charitable purposes, creating matching funds to stimulate endowments in existing charities, seeking gifts from national foundations and increasing the opportunity for gifts from large employers who are based elsewhere.

#### 2000

TCF launched two of its initial programs in the community. It partnered with the Schusterman Foundation to provide school supplies for students at Tulsa's highest poverty elementary schools. The program, known as PASS and Supplied for Success, has distributed over 540,000 sets of supplies to students since its inception. TCF then established the Heating Bill Assistance Fund with support from a dozen Tulsa-based oil and gas companies to distribute in excess of \$600,000 to help cover unexpected increases in winter heating bills.

# 2008

Through partnership with Tulsa Area United Way, TCF awarded \$750,000 to nonprofit groups through the **Ice Storm Relief Fund**. In subsequent years, TCF established and administered numerous other funds to assist with mid- to long-range recovery efforts after such disasters as the 2011 Joplin tornadoes, the 2013 Moore tornadoes, the 2019 Eastern Oklahoma Floods, the onset of COVID-19 and the 2023 Wind Storm.

# 2005

In its sixth year, TCF became **one of the nation's five largest community foundations** with assets of approximately \$1.2 billion. In 2005, TCF issued \$40 million in grants and received \$770 million in contributions. A year later, in 2006, the organization would become the **nation's largest community foundation.** 

#### 2010



TCF led efforts to privatize the management of Tulsa Zoo to create a private-public partnership to improve exhibits and amenities as well as ensuring the highest level of animal welfare and care.

Also in 2010, **ONEOK Field** opened in Tulsa's Historic Greenwood District. The stadium's construction was managed through TCF which accepted private contributions for the project, illustrating another successful private-public partnership structure under TCF.

"...what has emerged, and what gets me most excited, is the relationship or the partnership we're starting to create with the public side. If we can feel comfortable with the city and the county and all the other government entities that are involved then we are very interested in partnering with them on civic enhancement, beautification and economic development activities....It is becoming my philosophy that philanthropy is not only just about social service safety net funds, it's also about civic enhancement and economic development."

# 2015



Arts Alliance Tulsa was initiated and incubated under TCF to help sustain Tulsa's thriving nonprofit arts community through united fundraising and support. Now its own independent 501(c)(3) organization, Arts Alliance Tulsa has provided \$3.2 million in funding since it was originally formed under TCF.

#### 2021



Through the work of many community partners, funds were raised and held at TCF for the construction and opening of **Greenwood Rising**, a state-of-the-art history center located at the heart of Tulsa's Greenwood District honoring the legacy of Black Wall Street before and after the 1921 Tulsa Race Massacre.

# 2009

TCF established **501technet** to provide nonprofit organizations in the Tulsa area with high quality donor-subsidized or partner-discounted technology expertise, products and services. 501Tech has provided IT goods and services to more than 500 agencies, distributed nearly 6,000 refurbished PCs and LCD monitors, and managed IT for 135 agencies.

# 2014



help area charities build their endowment funds, TCF's **Endowment Challenge Program** celebrated \$40 million in planned giving pledges for area nonprofits in 2014. To reach this point, the program offered challenge grant opportunities to organizations in 2001, 2006, and 2012. To date, \$180 million in pledges have been made through this program to support the future of nonprofits in our community.

#### 2018



Gathering Place officially opened to the public as a "A Park for All." The project was administered through the George Kaiser Family Foundation, a supporting organization of TCF, and involved the collaboration of more than 80 corporate and philanthropic organizations. In total, \$465 million was raised for the historic project which saw 3.3 million visitors in its first year.


